Adults Who Experienced Four or More Adverse Childhood Experiences (ACEs)	Adverse Childhood Experiences (ACEs) include experiencing abuse and/or neglect (emotional abuse/neglect, physical abuse/neglect, sexual abuse) or household challenges (intimate partner violence, substance abuse in the household, mental illness in the household, parental separation or divorce, incarcerated household member) in the first 18 years of life. Data are from the Florida Behavioral Risk Factor Surveillance System (BRFSS) Adverse Childhood Experiences (ACE) Report.
Arrests for Non-Forcible Sex Offenses	Number of arrests attributed to non-forcible sex offenses. Data are from the Florida Department of Law Enforcement.
Arrests for Prostitution	Number of arrests attributed to prostitution. Data are from the Florida Department of Law Enforcement.
Child Intakes Accepted for Child-on-Child Sexual Abuse	Number of child intakes related to child-on-child sexual abuse accepted by Child Welfare Hotline staff and referred for investigation. Data are from the Florida Department of Children and Families.
Children Under 18 in Foster Care	Number of children under age 18 in foster care. Data are from the Florida Department of Children and Families.
Commercial Sex Acts Offenses	Number of offenses attributed to commercial sex acts. Data are from the Federal Bureau of Investigation.
Emergency Medical Service Responses to a Suspected Non-fatal Drug Overdose Including Opioids	Number of patients with an identified drug overdose (opioids or other drugs) during an emergency medical service transport. Data source: Florida Department of Health, EMSTARS.
Estimated Seriously Emotionally Disturbed Youth Ages 9-17	This is the estimated number of youth ages 9-17 years old with a serious emotional disturbance with substantial to extreme functional impairment. The estimate is based on a report called Mental Health, United States, 1996 from the Department of Health and Human Services which found that conservatively, 9% of the population ages 9-17 years old are affected. Using the 9% estimate results in rates for all counties being equal. The change in numbers over time is directly reflective of the change in population of that age group rather than a change in the mental health status of the population. Data are from the Substance Abuse and Mental Health Services Administration.

Estimated Seriously Mentally III Adults	Serious mental illness among people ages 18 and older is defined as having, at any time during the past year, a diagnosable mental, behavior, or emotional disorder that causes serious functional impairment that substantially interferes with or limits one or more major life activities. Serious mental illnesses include major depression, schizophrenia, bipolar disorder, and other mental disorders that cause serious impairment. These counts are based on prevalence estimates from the Substance Abuse and Mental Health Services Administration (SAMHSA).
High School Students Who Have Experienced Four or More Adverse Childhood Experiences (ACEs)	Data about the High School Students Who Have Experienced Four or More Adverse Childhood Experiences (ACEs) come from the Florida Youth Substance Abuse Survey (FYSAS). The data are summarized from a statewide, school-based survey effort to assesses risk and protective factors for substance abuse, including substance use prevalence, alcohol, prescription and illicit drug use among youth. Schools and classrooms are randomly selected and the survey responses are anonymous. FYSAS collects state-level data during odd numbered years and county-level data during even numbered years.
Homeless Estimate	The estimated number of people who are homeless. Estimates are derived from a point-in-time count of homeless people. Data are from the Florida Department of Children and Families, Office of Homelessness.
Hospitalizations from Mental Disorders (Aged 0-17 Years)	Hospitalizations from Mental Disorders (Aged 0-17 Years) are a count of the hospitalizations with a primary diagnosis of a mental disorder among people less than 18 years old who were discharged from civilian, non-federal hospitals and include visits with ICD-9-CM Codes 290-319 listed as the principal diagnosis or ICD-10-CM Codes F01-F99 listed as the principal diagnosis.
Human Trafficking Related Emergency Department Visits	Complete annual data for human trafficking-related emergency department (ED) visits are available starting with 2019 and include ICD-10-CM Codes T74.51, T74.52, T74.61, T74.62, T76.51, T76.52, T76.61, T76.62, Y07.6, Z04.81, Z04.82, Z62.813, Z91.42 listed in the primary diagnosis, secondary diagnosis, or external cause fields among Florida residents. Data may contain multiple ED visits for the same person/injury event due to hospital transfers, readmissions, and follow-up visits. Therefore, the data reflects the number of ED visits and not the number of people injured. Some of the ED visits may not have a confirmed or suspected code present with codes related to perpetrator, encounter for examination and observation of victim following forced sexual or labor exploitation, and personal history of forced labor or sexual exploitation. Counts less than 5 are suppressed. Data are from the Florida Agency for Health Care Administration.

Data may contain multiple hospitalizations for the same person/injury event due to hospital transfers, readmissions, and follow-up visits. Therefore, the data reflects the number of hospitalizations and not the number of people injured. Some of the hospitalizations may not have a confirmed or suspected code present with codes related to perpetrator, encounter for examination and observation of victim following forced sexual or labor exploitation, and personal history of forced labor or sexual exploitation. Counts less than 5 are suppressed. Data are from the Florida Agency for Health Care Administration.
Involuntary Servitude Offenses	Number of offenses attributed to involuntary servitude. Data are from the Federal Bureau of Investigation.
Labor Trafficking Cases	Number of distinct situations of trafficking reported to the National Human Trafficking Hotline that involve one or more potential victims of labor trafficking. Situations, or cases, can be reported to the hotline through one or more conversations via call, text, email, online report, or webchat.
